## **Increasing Cultural Competency in Working with LGBTQ Population**

Carrie will provide information regarding best practices in working with sexual and gender minority populations, often referred to as LGBTQ (Lesbian, Gay, Bisexual, Transgender, Questioning/Queer). The presentation will include an overview of sexual and gender diversity, the development of gender identity and sexual orientation of individuals, and an introduction to the use of SOGIE (Sexual Orientation, Gender Identity, and Gender Expression) and other assessment considerations.

Objectives for "LGBTQ - Affirming Practice: Considerations for Working with Sexual and Gender Minority Populations":

- Attendees will be familiar with terminology associated with sexual and gender minority populations and will be able to use appropriate terminology in working with clients.
- Attendees will be able to utilize SOGIE in their work with clients.
- Attendees will understand how sexual orientation, gender identity, and gender expression differ but are also related.
- Attendees will have a better understanding of how to implement LGBTQ-affirming internal forms, tools, and policies.

## Trauma, Therapeutic Interventions & Differences between PTSD & Complex Trauma

Associate Professor of Psychiatry & Behavioral Sciences, Tulane University  
Dr. Murphy will present an overview of trauma and post-traumatic stress disorder (PTSD) in children, ages birth - 18 years of age, with a specific focus on children under age six. The presentation will describe the symptoms of and clinical presentation of PTSD, discuss screening and assessment of PTSD, and provide an overview of therapeutic interventions for PTSD. Differences between PTSD and "complex trauma" will be discussed.

### Objectives for the Training:

- Participants will be able to describe the core symptoms of post-traumatic stress disorder in children and adolescents.
- Participants will be able to administer the Child PTSD Checklist and the Young Child PTSD Checklist for screening youth with histories of trauma.
- Participants will be able to identify three key components of Cognitive Behavioral Therapy for PTSD for children and adolescents, including relaxation techniques, cognitive restructuring and planned hierarchy of exposures.
- Participants will be able to describe the key differences between PTSD and other affects from "complex trauma."
