A Personal Counseling

Statement

An effective counselor must learn how to slow time with every student they seek to help. It is as necessary as



learning to gauge a client's commitment to actively affect change in their lives once alternatives and consequences are discussed. Sometimes these lifealtering discussions happen in short term sessions, some are parlayed into long term therapy. The uncertainty within those uncharted waters is what makes counseling so appealing to me. How to guide them, and what tools do we use? How to listen to them without having already formulated a response? How to let them discover ways to resolve problems without acting as their perennial problem solver?

It has taken twenty five years of counseling practice to realize that I have been a counselor most of my life. Whether it was mediating within my family of 5 siblings or negotiating boundaries between adolescent couples or between them and their parents; counseling in that most primitive form only whet my appetite for more. College counseling has been the most rewarding part of a rewarding professional life. Though certain that I have not reached every person that has sat with me, the challenge and desire to help others find peace and/or acceptance still rings as true now as when I began at LSU. As I grew into my profession, I began to realize what a responsibility I had to the future of the planet, but mostly, to the present quality of life of each person that sought my coun-

# Mini Minutes from LCA Executive Board Meeting

The LCA Executive Board Meeting was held at the West Baton Rouge Conference Center in Port Allen, Louisiana on February 19, 2016. In the absence of Tim Fields, LCA President, John Crawford, Past-President, called to order the meeting.

The Board conducted the following business on behalf of the Association:

Austin White, Business Manager, presented the Financial Report and the 2015 Conference Financial Report. Both reports were accepted. The conference allocation was voted on and approved for payout based on net income of \$102,867.25. LCA received a profit of \$80,136.84. The remainder will be disbursed to the divisions based on the number of division members attending the 2015 Conference. The disbursement to the divisions will be:

how it fit their goals and dreams – to make them more accountable in their lives. They had to learn perspective; and maybe different ways to manage unfamiliar territory, like most every new college student in this new millennium.



I know that it is quite a lot to chew on, but whether

we are conscious of it or not, it is on the table every time a 'client' enters our office. My job is to be professional, welcoming, knowledgeable, and patient with every student or client who seeks my assistance. If I can will that to happen more often than not, then the likelihood of them experiencing positive change, perhaps even resolution, increases with every client that comes through my door.

#### **Strategic Planning**

"Begin with the end in mind."

— Stephen R. Covey

Have you ever taken an impromptu road trip? The kind where maybe you wake-up in the morning realizing that you have a free day and you grab a bottle of water and some money and just take off, destination undetermined? Or are you the type that likes to plan, always have a destination, a route to the destination, and at least some thoughts about your stops along the way?

Stephen Covey (2004) writes in The 7 Habits of Highly Effective People, that we should begin with the end in mind. The principle suggests that all things are created twice. First it is created in our minds. We conceptualize our destination, our goal, the end product, etc. The second creation is the physical creation. Our vision comes to fruition as a product, goal attainment, or arrival at our destination.

There are many forces that frequently prevent us from creating twice and beginning with the end in mind. Two of the most common are simply our own personality preferences and the other is the taxing demand on our time.

Covey (2004) suggests that mission statements can help provide the organizing picture in our minds to frame our first creation, our vision. Our mission statements help us stay rooted in our core values and decide when to say both yes and no. They help us decide which routes to take, which products to create, or which goals to pursue.

The mission statement for LCA reads: "The mission of LCA is to enrich the life processes and to advance the profession of counseling within the state of Louisiana." This mission is the guide for all of us providing leadership in the organization. It provides the framework for which we can vision the future of LCA and the action of our divisions. It is an exciting time to be part of the LCA as we continue to develop strategy to accomplish our mission. It is a good time to remember our vision and make sure that we always begin with the end in mind.

Personal checks will no longer be accepted onsite to pay for conference registration. School and agency checks, credit cards, purchase orders, money orders, cash are acceptable for payment of onsite registration. Poster Sessions will be reinstituted. After reviewing the registration fees for 2015, the online fee will remain the same and only the hard copy registration will increase. #### LCSJ: In a "Front Row Seat"

As we continue with a very successful year in the Louisiana Counseling Associ-



ation, it is very worthwhile to note important issues in our state which very much impact our clients and families we serve, and things that may also affect the most marginalized among our citizens. The Louisiana Legislature met in special session in order to address a mid year budget deficit and address a major budget deficit for the next fiscal year. The need for our services does not go away, and we must find ways to continue to serve our clients in caring and professional ways. Please be alert to the issues facing your legislators and communicate with them now and in the regular session and probably in another special session before the summer! Recall that the regular session does not permit tax increases this year.

It is also important to note a significant issue for Louisiana, which has just been resolved by the U. S. Supreme Court. If you want to get into more detail, I can email you a syllabus of the case. In brief, the case is Montgomery v. Louisiana, and it has to do with juveniles who were convicted of crimes when they were juveniles, and who were tried as adults. In an earlier case, the U.S. Supreme Court said that if a juvenile was convicted of a crime, he or she could not be given a life sentence without the possibility of parole. The Louisiana Supreme Court decided that such a decision only applied to cases decided after the SCOTUS decision, hence the appeal by Mr. Montgomery. The Supreme Court said that upon application, that offenders so situated must be given the possibility of parole. I understand that does not mean that there will be a mandatory resentencing, but that a hearing is required. Please know that I am not an attorney, I am just calling your attention to a very significant case.

As I sat through the commercial, the segment troubled me. How eager the audience members wanted their lipsticks analyzed, how pleased they were to be flattered for their hidden personality assets. If you are like me, you have several tubes of lipstick, and probably none of them are very new. But I happened to have a new sample tube I had not yet opened, so I tested my hypothesis. And voilé, new lipstick starts with that desired slanted shape. If you tend to use your lipstick to line as well as color your lips, you probably use your lipstick in a way that maintains or sharpens that original angle. If you simply color your lips, you likely wear your tip into a more rounded shape.

Counselors are students of human nature. Having spent my life as a school counselor, I have found it very helpful to encourage self-reflection and self-exploration among clients as a way to improve decision-making and goal-setting. But there is also so much junk science published in magazines, posted on websites and yes promoted on TV shows by "experts" who are supposed to know. It is very important that we continue to urge those with whom we work to apply critical thinking to any analysis of their mental health.
