What is Humor Therapy? Humor therapy is the term given to a therapeutic process which claims beneficial effects from the use of positive emotions associated with laughter.


Therapeutic Use Of Humor Throughout History

Biblical Times: The benefit of humor makes an appearance in the Good Book itself: The Book of Proverbs 17:22 states 'A cheerful heart does good like a medicine: but a broken

- 30 16th Century: Robert Burton, an English parson and scholar used humor as a cure for melancholy.
- as part of his pastoral counselling of depressed people. He advised them not to isolate themselves but to surround themselves with friends who could joke and make them laugh.
- 20 17th Century: Herbert Spencer, sociologist used humor as a way to release excess tension.
- 29 18th Century: Immanuel Kant, Germany philosopher used humor to restore equilibrium.
- 18th Century: English physician William Battie used humor in treatment of the sick.
- 20th Century: Modern humor therapy dates from the 1930s, when clowns were brought into U.S. hospitals to cheer up children hospitalized with polio.
- **20th Century 1972:** The Gesundheit Institute is founded by U.S. Doctor Hunter 'Patch' Adams: this is a home-based

wards a restructuring of LCA dues. A dues structure and language to be included in the LCA By-Laws were drafted and presented at the general membership at the 2014 Annual Conference. The membership voted to accept the proposed dues structure at the conference. The structure is as follows:

Professional Members - \$50.00 Regular Members - \$50.00 Retired Members - \$30.00 Student Members - \$30.00 Counselor Interns - \$30.00

The membership also agreed that Beginning July 1 2015 the dues will increase 10.00 every two years until prof. dues are 80.00; other categories will be raised \$5.00 every two years until they are \$45.00.

to address issues which involve his experience, strength, and hope in his professional and/or personal life in which principles of Social Justice/Restorative Justice are employed.

This year, we were privileged to have Mr. Welborn Jack, Jr., Esquire, a well known defense attorney who has represented many inmates who would otherwise have been killed by the state. His presentation was passionate and riveting, and he made a call for counselors to consider being available as "mitigation specialists" in order to assist attorneys in their defense of the client. In capital cases now, such services are required to be made available to the defense attorney as part of his representation of the client. The goal is to present to the court a clear picture of the entire life of the person charged with such a serious offense.

We were favored by the attendance at the summit by past presidents of LCA and a future president of LCA. So, both the audience and the speaker were luminaries!

Much of the work of social justice is not glamorous, but it is compelling and passionate, and an integral part of the counseling profession. Because, as we all know, advocacy for our clients is endemic to our profession in service to our clients and their families. It is great when we can hear of significant efforts being made by counselors, attorneys, and other professionals, who bring social justice principles to what they do every day.

You can do yourself and your colleagues a favor by joining LCSJ and inviting others to join. Dues are minimal, only \$5 a year, and Diane Austin can include those joining at any time of the year. As a Division, we maintain archives of articles, assist in research, and share best practices.






