LCA Board Mini Minutes Diane Austin, LCA Executive Director

The LCA Executive Board held the Winter Board meeting March 2 in Baton Rouge. The following business was addressed:

- In the absence of Cindy Nardini, Chair of the Gratitude Project, Adrianne Trogden reported that Mrs. Nardini was planning to complete a Gratitude Project for April which is Counseling Awareness Month.
- Adrianne Trogden, President Elect 2019-2020 reported that the 2019 conference had been scheduled for September 28-October 1, 2019 at the Sheraton Canal Street in New Orleans.
- Vinetta Frie, President Elect announced that the theme for the 2018 conference. The keynote speakers for the conference are Julia Cook, Dr. Sherene McHenry, and Dr. Simone Lambert.
- Registration Fees: A motion was made by Lisa Hibner and seconded by Joan Gallagher to raise the registration fees by \$10.00 per category. The motion also called for the printed conference program to be offered for \$5.00
- Division Presidents and President Elects will receive a form for Division Needs.
- City Year was selected as the Community Project. In addition to monetary contributions, we can donate school supplies.
- The board suggested that an attempt be made to find a local organization which would film the conference to put sessions on the web site for CE clock hours following conference
- Austin White reported on the 2017 conference financials. The profit from the conference is \$86,333.19 which will be divided

among the divisions and LCA. LCA will receive \$64, 749.89 and 21.583.30 will be divided among the divisions based on the division attendance at conference.

- LCA's total distribution for 2018 is \$77,019.89
- Eric Odom spoke to the Board concerning diverse revenue streams. While LCA has non-membership related revenue, they mostly related to advertisement on the web site, newsletter, Journal, and e-blasts. A committee was formed to explore. The committee includes: Eric Odom, Chair, Christine Ebrahim, Zach Hebert, and Nikolya Sparks.
- Lisa Hibner, President of LCDA, brought a motion from the LCDA Executive Board asking that LCA would approve allowing nonmembers of LCA to join LCDA. The rationale was that many of the employees of the College Career Centers were not trained mental health counselors and not eligible to be members of LCA. As this matter was discussed, it was decided that these individuals could join LCA as a Regular member rather than a Professional member. A motion was made by Adrianne Trogden and seconded by Zach Hebert to change the name from Regular to Affiliate.
- Leah Rose, Strategic Plan Committee chair, announced that a strategic plan was a working document.
- A motion was made by Leah Rosa and seconded by Stephanie Robinson to accept the plan as presented and to view it as a working document subject to change when necessary.
- In the absence of Mary Feduccia, Joan Gallagher reported that the Government Relations Committee was working closely with LSCA to having the language in Bulletin 747 changed to add PLPCs to the list of professions which could be hired. She also re-

Opening My Eyes

Recently I had the opportunity to travel to Bhutan, Asia to attend a conference. This trip to Asia has been one of the most impactful and eyeopening travel experiences that I have embarked on. As I traveled through South East Asia. I'm not sure if it's the people you meet along the way, the beauty of the countries you visit, the once-in-alifetime experiences you embark on, or a combination of them all that really made my east Asian trip all that more special.

Bhutan is a country I knew little about and few people could tell me about this or even where it was on a map. Flying into the Himalayas is an extraordinary experience. To say it's beautiful is a bit of an understatement. It's stunning, and it truly looks untouched. However, it should be noted that it is extremely difficult to get to Bhutan from another country as there are only a limited number of flights that come into the country.

Flying to Bhutan consisted of flying from Houston to Chicago to Hong Kong to Bangkok to Paro, which took well over 24 hours to do. This was my first flight over the Pacific to Asia and this flight was long. However, I enjoyed aspects of the flight as they provide meals and drinks to ALL passengers, in addition to free television. The view of flying into Bhutan was amazing but a little scary if you do not fly in planes often. Other than this, the Paro airport has beautiful architecture beautifully representing the Bhutanese tradition. Upon arrival into Bhutan, you cannot help but to notice that all of the buildings are constructed in the typical Bhutanese style, like a page of a story book or a photo you would see in a museum. The river that runs through the Paro Valley looks like one of those fake rivers that you see on a train set. Its edges are perfectly defined, with beautiful buildings on either side. After only two days, I learned a lot about the country and really appreciated this opportunity to come and explore one of the least visited countries.

-utes on page 2, she mentioned the 2017 Annual Fall Conference was a financial success. When that happens, LCA splits that profit 60/40 with the Divisions. The division gets a portion of that 40% after any conference expenses accrued by that division. The net rebate is determined by the number of members who indicate a primary division. So the more members a division has attending the conference AND indicating a primary division on the conference registration form, the larger the division's rebate!!

Each year, some conference attendees fail to indicate their primary division. LCA Business manager, Austin White has also created a formula to divide this smaller pool of money. This second rebate is also divided among the divisions.

This practice has helped many divisions provide services to their members without having to raise dues! See chart on page 13 to see the share your Division will get!

April is Counseling Awareness Month. In an effort to celebrate the amazing work done by Louisiana counselors and to enrich the lives of those counselors and the people they serve, LCA is pairing the Gratitude Project with the month of April.

The original Gratitude Project was inspired by Ron Cathey in 2008 during his year as LCA President. *"Gratitude: the power to heal, energize, and change lives"* was the theme of his conference. A video, group prospectus, note cards, and posters were created to define gratitude and point out the benefits of the personal practice of gratitude. Robert Emmons, Ph.D., researcher of the quality of gratitude, was a keynote speaker at that year's conference. Emmons states that it is helpful to conceive gratitude in two stages: (1) gratitude is the <u>acknowledgement</u> of goodness in one's life, and (2) gratitude is recognizing the source(s) of this goodness lie at least partially outside the self.

During the month of April we are inviting you to go on the LCA website and view the gratitude video and to use the 30 Days of Gratitude as a guide to practice gratitude in your life. As you incorporate gratitude in your daily life we encourage you to share the effect on social media. We also encourage you to share the video and 30 day guide with anyone and everyone in your community – family, clients, students, friends, social groups, churches, co-workers, etc. By doing so we hope to enrich the lives of Louisiana counselors as well as spread the message of gratitude to those around us. Can We Talk?

Over the past few months, we have all paid close attention to the ongoing highprofile news and heightened na-

tional conversation regarding harassment. It is a critical moment for our country to talk about this important issue. It's also for each of us as Clinicians to ensure that we are fostering a culture where our clients feel secure, cared for, respected, and safe. We should also recognize that harassment may take on many shapes, as does underreported abuse and exploitation. The trending, #<u>MeToo</u>" Social Media Campaign became the catalyst for change and pulled back the covers on some of the untold secrets of workplace harassment, domestic violence, and sexual assault. It has been reported that many persons once celebrated in Hollywood have abused the authority of the relationship with someone seeking stardom/fame.

Can we talk frankly? How often have you seen this play out in your office? It doesn't necessarily have to be a movie role. You may see it manifested as a person who sought a job promotion, the promise of a better life, the escape of the abusive father or brother...these stories are real and touch us every day.

There are those who may not be able to or are unready to disclose. <u>Human Trafficking</u> is more prevalent than ever within our beloved State of Louisiana. There are two types of trafficking: sex and labor.

"Human trafficking occurs when a perpetrator,



often takes any one of the enumerated 'Actions' and then employs the 'Means' of force, fraud or coercion for the 'Purpose' of compelling the victim to provide commercial sex acts or labor or services." – Polaris Project

State Law

Louisiana's Criminal Law RS 14:46.2 on human trafficking states that it shall be unlawful:

- (1) For any person to knowingly recruit, harbor, transport, provide, solicit, receive, isolate, entice, obtain, or maintain the use of another person through fraud, force, or coercion to provide services or labor.
- (2) For any person to knowingly benefit from activity prohibited by the provisions of this Section.
- (3) For any person to knowingly facilitate any of the activities prohibited by the provisions of this Section by any means, including but not limited to helping, aiding, abetting, or conspiring, regardless of whether a thing of value has been promised to or received by the person.

The 2018 Louisiana Legislative Session that began on March 12 will hopefully be a

little quieter than last year when we had a major bill passed that changed the language in the LPC Practice Act. So far this year we are tracking 16 mental health bills and are in support of some of them and opposed to others. We're working closely with our lobbyists, David Tatman and Jamee Blink. As a member of the LPC Government Relations Committee, I've had the pleasure of working with the new Executive Director of the LPC Board, Jamie Doming. As you may know, Jamie replaced Mary Alice Olsan who transitioned to a job with NBCC. Another newsworthy item is that we are again co-hosting the annual Mental Health Legislative Forum in collaboration with LAMFT and NASW-LA.

You may be wondering how you can support the advocacy and government relations' efforts of LCA. First, please read the weekly or bi-weekly enews sent to you by the Tatman Group on behalf of LCA to keep abreast of important legislative developments that affect us and/or our profession.
